A limited number of moorings are available for rent by GBYC members during the Club season (May 15 through October 15). Information concerning current rental fees may be obtained from the Club Mooring Chairman or Assistant Mooring Chairman.

The Great Bay Yacht Club and the owner/renter agree that the yacht, as described on the attached Mooring Rental Form, may anchor at an assigned mooring subject to the following conditions:

\* Anchorage at GBYC mooring is accepted at the sole risk of the owner/renter, and the owner/renter hereby releases the Great Bay Yacht Club, its officers, and members, from any and all claims for loss or damage, however caused.

\* The Great Bay Yacht Club assumes no liability for fire, theft, collision, vandalism, deterioration of equipment, or acts of God while the above yacht is anchored at a GBYC mooring.

\* The owner/renter fully understands that the Great Bay Yacht Club does not in any way guarantee, nor can it be held liable for the condition or reliability of the mooring in question.

\* The Great Bay Yacht Club assumes no liability for personal injury or loss of life to the owner/renter, his/her guests, servants, agents or employees during anchorage at the GBYC mooring.

\* The owner shall pay all costs involved should it be necessary for the Great Bay Yacht Club to take legal action to collect overdue accounts.
